Cold Weather Safety Tips

Heating is the second leading cause of U.S. home fires, deaths & injuries. Space heaters account for approximately 40% of these fires-most being placed too close to combustibles-three feet minimum away from anything that may burn is generally required- follow manufacturer's guidelines. Have a portable fire extinguisher and know how to use it correctly
Carbon Monoxide-THE SILENT KILLER- odorless, colorless, tasteless gas that comes from improperly burning fuels such as propane, natural gas, gasoline, wood, coal, etc. Heating and cooking appliances are among potential sources of CO. Every home that burns fuel should have a working Carbon Monoxide detector.

Information**

Tax collection for the City of Germantown is conducted by CCA-Division of Taxation.

Federal, State, City tax filing deadlines have been officially changed to **April 18, 2022**. City Tax forms are available at City Hall, Germantown Post office and on their website CCAtax.CI.Cleveland.oh.us. City Income Tax assistance dates will be posted soon.

REMINDER: The City of Germantown has a mandatory filing requirement even with no earned income.
