Devin Reported:

- We had a very busy season due to great weather.

Business:

Several items were talked about to replace and or add to the budget for next season:.

- New vacuum for the deep end
- Freezer to replace the one in the concession stand that is broken and unfixable
- Redo of the floor in the concession stand
- Hot Dog roller
- Baby pool is in need of many repairs beginning with the pump for the mushroom and replacing concrete to add filtration to the zero entry
- Steps for Seniors/Special needs to get in and out of the pool easily

Jason Reported:

- With the new system there was a huge difference in pool clarity
- Still working through slight issues with chemical supply and how much more is needed to run the new system and the cost of delivery of the chemicals from Spear.

Board Members Comments:
