

## MUNICIPALITY OF GERMANTOWN COUNCIL

MONDAY, APRIL 18, 11

The Municipality of Germantown Council met in work session on April 18, 2011 at 8:01p.m. in the Municipal Building Council Chambers.

### **MEMBERS PRESENT:**

### **TELEVISIONING WORK SESSION**

Mr. Boeder stated that he has spoken with some residents that feel that not televising the work session is an issue. There is no direct communication with the Village residents. Many residents want to support the Council in many activities and give Council their feedback. Residents would rather stay at home and watch it on TV then to come down here to the Village building.

Council discussed televising the work session. It was determined that the Law Director will look into Council overriding the Mayors decision to not televise the work sessions.

### **OTHER BUSINESS:**

#### **CAMP MIAMI LAW SUIT**

The Law Director spoke with Lynette Dinkler regarding the Camp Miami law suit and according to her the law suit is just sitting there. Nothing is really going on.

#### **VILLAGE CREDIT CARDS**

The Law Director stated that the Manager asked him to look into the Village credit card that was issued to Scott Pickup. The Law Director has made contact with the credit card company and they will not cancel the credit card without Scott Pickup's consent. The Law Director will contact Scott Pickup himself and ask him to please contact the credit card company and to cancel the credit card that is in his name.

#### **ZONING PERMIT**

Mrs. Sizemore stated that Mrs. Novak issued a zoning permit to the residents at 218 North Main in error. This permit allowed the residents to put an accessory structure in the front yard of the property. According to the Zoning Code this is not allowed. The Law Director is already involved in this issue but Council will need to decide how to resolve it.

After a discussion it was determined that the Village would purchase the accessory structure from the resident.

Mr. Boeder stated that he would like the Manager to please update Council on various projects that are going on in the Village in the memo that is sent to Council.
