Franklin Regional Wastewater Treatment Plant to Evaluate Moratorium

Lynette Dinkler questioned Dan Miklos from Franklin Regional Wastewater and Ken Griffiths, City Engineer, regarding the issues with the infrastructure of the City. They each suggested that if the funds were available to the City many tests would need to be performed such as smoke tests, manhole surveys and flow meter testing. Dan Miklos stated that the total estimated cost for just testing the City's sewer issues would be approximately \$180,000 to \$200,000.
