CITIZEN'S FORUM:

He spoke with the Manager and she was going to ask the Engineer why he had recommended so many signs to be located in this area. The Manager asked that he email her a letter with his concerns so that she could forward it to the Traffic Engineer. He handed a copy of his email to Council for their review. The Manager did email him back to let him know that the email had been forwarded to the Engineer.

Mr. Deeter stated he has lived at this property for 26 years and he knows of a few accidents but he does not know of any accidents that would have been due to the slight curve. He does not feel that the accidents that he is aware of justify the 7 signs on his property and the 5 on the

neighboring property. The location of the signs would/could make blind spots for him leaving his property. These signs are hideous looking from his front porch. If he felt that this was a dangerous curve he would not object to these signs. He suggested a white line, reflectors or even a small guard rail. He would like to suggest these other ideas to the Traffic Engineer.

Mrs. Sizemore stated that she has a call into the Traffic Engineer and will contact Mr. Deeter.
