POLICE CHIEF'S REPORT:

Chief McGill handed out the October Police Department Report.

He went on by saying that there has not been a homicide in Germantown since 1980. However last week there was child of approximately 22 months transported by our EMS to the hospital for injuries. Since that time the child has passed away due to those injuries. There is an ongoing investigation by our department and other local officials. At this time there will not be any press release or any more information giving publically until he has something significant to report.

MAYOR'S REPORT:

Jonathan Moore and he attended the FRWWC meeting a few weeks ago. Cheryl Shields gave a summary of the monthly operations. Bill Coleman was supposed to attend the meeting and discuss upgrading the plant. He was unable to attend but will hopefully attend at a later date. We are considering negotiating with Viola to continue operations.

This information would also be beneficial to all the members of FRWWC. Mrs. Sizemore replied that she would contact FRWWC and get information for Council to review.

Mayor Landis read the highlights of Dan Nicholas's, with Hazen and Sawyer, letter. These upgrades consisted of screening of grit removal, irrigation of basins and other various items.

COUNCIL MEMBER'S REPORT:

Mr. Boeder's Report:

He stated that he attended the Cemetery Board meeting. We were dismayed by the outcome of the levy. We will bring it back at the appropriate time.

He attended the Clean Ohio Program with the Manger today. The acquisition of the area adjacent to Kercher Park was straight forward. He had mentioned the interest of a dog park somewhere. They advised purchasing the land for a dog park and not include it with this possible project. The potential of acquiring Camp Miami and the demolition of the buildings was also discussed. We possibly could get assistance for the demolition expenses of Camp Miami. This would have to then be used as a park or grass land. Council may want to consider this as an option. The browns field option is an option but we will need to apply for the Clean Ohio Funds through Montgomery County. When you apply for the browns fields program, you are in competition with all the applications throughout the state. The lady was pointing us in the direction for demolition with the Clean Ohio Program. The Clean Ohio Program, since it is bonded and approved by the State, the monies are available immediately. We can proceed with that. At this point in time Council needs to review the options and have some open discussions. The deadline is in February and they are willing to work with us in preparing the application.

He is planning on attending a meeting in Piqua regarding small community funding. He will update Council on this information at the next Council meeting.

He would like to discuss the minutes again during work session.

Mr. Johnson's Report:

He attended the Park Board meeting this month. The Christmas in the Park event was discussed and plans are still being finalized. Santa and Mrs. Clause will arrive at 6:00 p.m. on December 7.

The Pool Board will meet on November 20.

He went on to congratulate Mr. Boeder on becoming Mayor.

He wished everyone a Happy Thanksgiving.

Mr. Koogle's Report:

The CBC met on November 13 to work on the fluffing and decorating of the potted Christmas trees. They are also meeting tonight to continue working on this project.
