He attended the MVRPC meeting, the Mayors and Managers Meeting and the MVCC Elected Officials Meeting. The main topic at the MVCC meeting was questions regarding the Sunshine Law.

Mayor Boeder briefly updated everyone on the topics of the last Work Session. The old water tower issue, Council has directed the Manager and the City Engineer to look into the purchase of a new tower and to apply for any available grants. The South Main reconstruction project, Council has directed the Manager and the City Engineer to look into a cost estimate to complete the project and then see how the residents feel about the project. Then we will look into a way to pay for the project. We are looking to have a street levy of our own and we have directed the Manager and the Finance Director to look at the millage that the City would need to generate to complete our projects. Camp Miami is a very sensitive subject and the Council is looking into what to do with the land and the building. Council will need to discuss this issue for any long term plans. The South Walnut drainage issue is going to be monitored closely by our Service Department and the Manager and Engineer will be looking into ways to correct the issues. The East Market Street Sidewalk, we would like to establish a continuous sidewalk from the downtown area to Route 4. We would also like the slippery sidewalk that is over the bridge corrected immediately. The Manager and the Engineer will look into a cost to complete the sidewalk on the North side to Route 4 and check with the State regarding a cross walk at Route 4. The Council Retreat items will be covered during regular Council Work Sessions. Delinquent water bills have been discussed and owners/landlords need to understand that they are responsible for any outstanding water bills. The Manager will be handling the notices to landlords/owners concerning outstanding water bills. Council discussed the snow removal/snow emergency routes. The Staff will get additional information on updates and report back to Council.

He announced that the City currently has many vacant seats for various Boards and Commissions and encouraged residents to apply for these seats.

He went on by complimenting Ben Mersch, with the Germantown Press, for his coverage of the State of the City address.

Mayor Boeder read the Fair Housing Proclamation.

Mayor Boeder read the topics of tonight's Work Session ethics filing, Camp Miami and address retreat topics/workload assignments.

COUNCIL MEMBER'S REPORT:

Mr. Heistand's Report:

He encouraged residents to volunteer for the many Boards and Commissions that have vacant seats. It is an excellent way to start in local government and to serve the community.
