He went on by saying that there were a total of 958 calls for the year and 750 of them were EMS calls.

**OVERSIGHT COMMITTEE MEMBER'S REPORTS:**

**Mr. Benson's Report:**

Mr. Benson questioned if the residents in the Township that live down lanes with multiple houses are marking their addresses clearly. Chief Alldred replied that they have not really gotten any worse or any better. When they have a call at one of these residents, he makes an effort to explain the need for well marked addresses at the roadside and that they have difficulty locating their address.

Chief Alldred went on by saying that they are experiencing problems with low branches down lanes that damage the equipment. This is a big problem when the equipment is unable to turn around and is getting damaged. We simply do not have the clearance we need. He has spoke with neighboring Departments and their policy states they will not damage their equipment for a single resident.

Mr. Benson suggested that Chief Alldred get information regarding the branch clearance issue and he will have it posted on the Township website.
