The Board thanked him for his service and wished him and his family well.

Mr. Heistand announced that USTA has a grant that assists communities with tennis court resurfacing. He will look into this and get additional information.

Mr. Kozarec reminded everyone that the Cross Country invitational will be at Kercher Park on September 13. He will contact the Service Director to organize the details for the event.

The Board discussed the upcoming Christmas in the Park event on December 3. They will get with Staff to discuss the details.

The Board discussed the 2017 proposed Budget. They made several suggestions to the Manager to consider in 2017. Including: work on tennis courts, parking lot extension at Weber, fence at Megan Lane, demo shelter at Hillcrest Park, work on basketball courts at Veteran's Park, resurfacing roads around Kercher Park.

They also discussed the upcoming Park Levy that will be on the ballot and asked that a brief article be placed in the newsletter asking for the residents support.

The Board discussed the issue of smoking in the parks. There have been several complaints of patrons smoking near the children in Kercher Park during events.

**MOTION:** Mr. Mersch moved to recommend that Council promote a smoke free environment in the City parks and property by adding "no smoking beyond this point" signage at Kercher Park, Veterans Memorial Park, the Weber Sports Complex and the bike path.
