EMERGENCY RESOLUTION NO. 08-57

A RESOLUTION AMENDING RESOLUTION NO. 08-23 REGARDING THE POLICY ON THE PLACEMENT OF BANNERS IN THE EAST MARKET STREET RIGHT-OF-WAY, AND DECLARING AN EMERGENCY.

NOW, THEREFORE, THE MUNICIPALITY OF GERMANTOWN, STATE OF OHIO, HEREBY RESOLVES THAT:

SECTION 1: Resolution No. 08-23 regarding the policy on placement of banners in the East Market Street Right-of-Way is hereby amended and shall conform to the specifications, rules and application attached hereto as "Exhibit A."

SECTION 2: This Municipality of Germantown finds and determines that all formal actions of this Municipality concerning and relating to the adoption of this Emergency Resolution were taken in an open meeting of the Municipality of Germantown and that all deliberations of this Municipality and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION 3: This measure is hereby declared to be an emergency measure necessary for the immediate preservation of the public life, health, property, welfare and peace pursuant to Section 2.05 of the Charter. Therefore, this measure shall take effect and be in full force from and after its passage.

13. A permit shall be obtained from the Village Manager a minimum of twenty-one (21) days in advance of the installation date desired. Permits shall be granted on a first come, first serve basis for the available dates.
14. Applications for such a permit must state:
 - A. The name of the organization sponsoring the event.
 - B. The dates requested.
 - C. The purpose of the event.
 - D. The exact wording on the banner.
15. A permit shall be granted for a maximum period of three (3) weeks. No organization may obtain more than six (6) permits in a calendar year.
16. Banners shall be delivered to the Village Clerk's Office, 75 N. Walnut Street, Germantown, Ohio, seventy-two hours prior to desired installation. Banners shall be picked up within forty-eight hours of removal.
17. No banner will be displayed containing political or religious material.
18. These guidelines have been established to ensure that quality banners are hung and to reduce the liability accepted by the Municipality in providing this service. The Municipality reserves the right to refuse any banner that fails to meet the above requirements.
