- A signed indemnification statement and copy of the liability insurance for the business in an amount not less than \$1 million, naming the Municipality of Germantown as an additional insured
- Proof of access to permanent restrooms for use by the employees, and with a hand sink for use by employees, as evidenced by written agreement between the vendor and the business or entity which will provide such access, if such restrooms are not provided by the employer on site
- A valid copy of all required license or permits required by governmental health or transportation authorities, including but not limited to the Public Health - Dayton & Montgomery County and the Department of Motor Vehicles
