- Failure to pay estimated tax payments totaling 90% of the current year tax due or 100% of the prior year tax due no later than 15 days after the end of your tax year may result in penalty and interest charges for underpayment of estimated tax in accordance with *Ohio Revised Code 718.08*.

EXEMPTION CERTIFICATE

- If you live in a mandatory filing community, you may not be required to pay municipal income taxif:
 - o You are retired and only received pension, Social Security, interest, or dividend income.
 - You are a member of the Armed Forces or reserve components of the United States for the entire year 2024. This does not include civilians employed by the military or National Guard.
 - o You are under 18 for the entire year 2024.
 - *If you turned 18 during 2024, and have taxable income, you will need to file a prorated return.
 - You have no earned income for the entire year 2024 (Public Assistance, Unemployment, SSI, etc.)
 - You closed a business or sold rental property prior to 1/1/2024.
