

**PARKS AND RECREATION BOARD  
MINUTES OF MEETING HELD JANUARY 6, 2016**

**APPROVAL OF MINUTES:**

**Mr. Heistand's Report:**

Mr. Heistand expressed concern of the excessive speed of vehicles driving in the park during tennis practice and/or matches. He asked that Staff supply him with signage that would redirect traffic and encourage them to slow down.

The Board would like to discuss the parking lot and drive ways of Kercher Park with the Service Director to get a clear layout of the park's traffic patterns.

He asked for a copy of the Parks and Recreation Board current Budget to review. Staff will look into obtaining a copy of the Budget for the Board Members.

**Mr. Shuey's Report:**

Mr. Shuey commented on the new concrete connectors along the bike path to the crosswalks. This is a great asset.

He would like to see more participation with the Christmas in the Park event. He asked that the preschool be invited to participate next year.

He questioned how VV Base was doing this year. Mr. Johnson replied that they are off to a great start. The fields have been seeded and are looking much better. We do need to look at replacing and/or repairing the fencing and adding additional dirt to some of the dugouts.

Mr. Geglein suggested that when the Municipality has a contractor do any work at the parks to please have the Service Director go to the park and sign off when the work is completed and is satisfactory prior to any payment.

**Mr. Williams Report:**

Mr. Williams shared photos of restrooms located in a City of Carlisle park. He thought that the design would be great for the Lions Club restroom project at Weber Sports Complex.
