Mrs. Gilleland announced that this meeting will be the final council meeting held in these Chambers. We will be moving the meetings to the new City Hall for the June meeting.

Administration offices have been moved to One North Plum Street and we are enjoying the new location. The Historical Society and other sources are assisting us in finding unique pieces of art work to compliment City Hall. We are working on selecting a date for an open house and plan to have it in the upcoming months.

She announced that the City has received another grant in the amount of \$15,000.00 from the US Tennis Association. This is in addition to the \$45,000.00 we received earlier and a small match from the City. We will be able to move forward with the resurfacing of the Kercher Park tennis courts with these funds.
